## President's Message

I cannot help but reflect on the many successes of this organization during the year. A more detailed summary will be provided in the next few months, but in a nutshell, here are the big highlights.

Our building hosted numerous events in 2018 consisting of our own events (e.g., Suds & Spuds, three dances, Trunk – or – Treat, monthly board and membership meetings, etc.), private weddings, and three major fundraisers for other organizations, such as The Mustard Seed Project, Evergreen PTA and The Longbranch Foundation. Not only was it busy, but all of the events contributed to building revenue exceeding budget for the year. A number of trail improvements were also made during the year, AND, the new “Longbranch” sign was placed on the property.

The marina has also turned in very good numbers for the year. While guest moorage is down slightly from last year, overall revenue is ahead of budget due to increased permanent and temporary moorage. This helps us in making a number of small, but very important upgrades during the year, such as the emergency boarding ladders at the marina.

Our membership continues to grow. Thus far in 2018 we have added 31 memberships representing 53 individuals. We are also poised to break the record of volunteer hours in 2017 (5,630 hours). This is incredible support for our community and this organization. I am in awe of the generosity of our members and commitment. Our members should also note that we have a few more events coming this year that will provide opportunities for you to put in additional volunteer hours, earn a few more “LIC Bucks” for 2018, and have fun in the process. We approved a new building rental rate schedule at our November member meeting. We are grateful to Bob Perry, Building & Grounds Chair, and Benita Parodi, Rental Agent, for the work and research they did to establish the new rates. This B & G Committee is still working on the feasibility of replacing the two leased propane tanks with one larger purchased tank and upgrading the propane piping to current code. When that is completed, implementation will allow us to shop for propane prices rather than being tied to one supplier, as well as improve safety.

On the REALLY GOOD NEWSFRONT, permits for our marina project are no longer hung-up in the bureaucracy at National Marine Fisheries Service (NOAA). We got our elected officials to help us prod NOAA, with the staff from the offices of Sen. Maria Cantwell and Rep. Derek Kilmer making a few contacts and within a couple of days, the permitting process moved forward. The next steps are for the Corps. of Engineers to pass on our approved application, Pierce County to issue building permits, and the WA Department of Natural Resources to give their formal blessing to the project. Our members have formally approved going forward with the marina projects and the contractor has been notified so they can begin sourcing materials needed for the upgrades.

Once again it's a good time of the year to reflect on how fortunate we are for many blessings, including this special community. Barb and I wish you all a Merry Christmas and Happy New Year!

## Recipe of the Month

Kelly Hettinger*

### Easy African Peanut Soup

- 2 Tablespoon Vegetable Oil
- 1 large yellow or white onion finely chopped
- 3-inch piece of ginger, peeled and finely minced
- 3 to 5 Garlic Cloves, finely minced
- 1 quart chicken stock
- 1 (15 ounce) can crushed tomatoes
- 3/4 cup crunchy peanut butter
- pinch of cayenne or to taste
- 2 cups diced or pulled rotisserie chicken
- salt and pepper

Heat the vegetable oil in a large soup pot set over medium-high heat. Saute the onion in the oil for 3 to 4 minutes, stirring often and scrapping any browned bits off the bottom of the pot. Add the ginger and garlic, and saute another 1 to 2 minutes. Add the chicken stock, crushed tomatoes, peanut butter and cayenne, and stir well to combine. Bring to a simmer and add salt and pepper to taste. Cover the pot and simmer gently for 5 to 10 minutes. Add the chicken to the soup and heat until warmed through. Add more chicken broth or water to achieve the desired consistency. Adjust black pepper and cayenne seasoning if desired.

## LIC General Meeting November 14, 2018



Clark Van Bogart called the meeting to order at 7 p.m. and greeted a new member, Leroy Sealey.

Francie Carr introduced the guest speakers: Sergeant and Deputy Stewart of the Pierce County Sheriff's Department. The following are excerpts from their presentation.

Five deputies across Pierce County constitute a community liaison team speaking at gatherings about public safety, stressing basic prevention.

- Appearance is everything: If the building is presentable - no broken windows etc. - criminals tend to back away. Do not leave your house dark or newspapers gathering in your yard. If possible, have packages delivered to the local post office, not to your house.
- Be sure to lock windows and doors in houses and automobiles. Install external alarms (or have dogs).
- Get to know your neighbors. Have a call list to notify each other - as well as the police - of a suspicious person/activity.
- Do not fall for scam calls from the I.R.S or F.B.I. For internet security, change your passwords regularly and do not write them down unless you can store that information in a secure place. Shred printed information (bank statements, credit card statements, bills etc.)
- Assume that the intruder has a weapon of some sort (anything from a screwdriver to a gun), call 911 and do what you think is best to keep yourself safe.

REPORT CRIME. If you do not report it, the numbers/statistics do not reflect the situation.

### OFFICER REPORTS

**Secretary:** Jane Eiseman asked that the minutes of the October general meeting be accepted as written and submitted. MSP.

**Treasurer:** Jim Hettinger announced that, for the year to date, we are about \$11,000 over budget for income: Building is over budget by about \$5,000; Events are about \$6,000 over net income for the year; Marina income is very close to budget for the year and should be at budget for expense.

**Vice President:** Marsha Kremen noted that a committee has been formed to tend and beautify the grounds of the LIC. Ann Morris is the organizer and the other members are Marsha, Jilly Eddy, Carolyn Carr, Kim Robinson and Kelly Hettinger. Volunteers are welcome.

### COMMITTEE REPORTS

**Membership:** Nancy Carr pointed out that there are volunteer forms on each table. Volunteers are needed to provide cooked turkeys and hams for the Christmas dinner potluck, which starts at six o'clock, December 12th.

**Events:** Bob Green thanked everyone who helped make Trunk or Treat a great success. There are sign-up sheets for volunteers for Dec the Halls and Kids N Christmas.

## LIC General Meeting November 14, 2018



**Building and Grounds:** Bob Perry was not present. He is working on a proposal for a new propane service. This would involve the purchase of a single propane tank, rather than the two leased tanks, which would allow us to shop for the best propane price. Bob and Benida Parodi (our Rental Agent) have come up with suggestions for revised rental rates for the building and/or the grounds, to increase revenue. Clark asked for a motion to approve the new rates. MSP.

**Sunshine:** Cheril Allen sent a card to a non-member, Phil Bauer.

**Newsletter:** Tanya Perry was not present. Clark reminded people to send in their submissions by the 25th of the month.

### **OLD BUSINESS**

In October of 2016, Clark made a presentation to the LIC membership that we were about to embark on applying for a \$240,000 grant from the state of Washington for repairs and upgrades at the Marina. Clark has received an email from Evan Smith, a legislative aide to Representative Derek Kilmer. The email states that the biological opinion is in the final stages of review. It is moving to QA/QC (Quality Assurance/Quality Control) and Legal staff for review and after that it can be signed. Evan Smith requested expedited processing: The biologist's opinion has been signed and sent to the Army Corps of Engineers.

Clark advised that some lead time is needed for the contractor to assemble all of the required materials for the project and asked

the membership to approve moving forward with the project. MSP.

Clark also reminded the membership that the grantee is The Longbranch Foundation.

### **THE LONGBRANCH FOUNDATION**

Kelly Hettinger reported on the Evergreen Elementary activity. The school has an outreach program in which you can participate on Thursdays, from four to five o'clock. It is an after-school crafts program at which you bring something to work on with one or more students. If you are interested in spending some time with elementary school students - who will definitely benefit from your interest in them - find a project (build a birdhouse, paint a rock etc.) and participate in this program. Also on the table was a flyer itemizing needs for the students - rain gear, boots, shoes, socks, hygiene kits. You can help these kids feel better about themselves with donations of cash or items.
