The first question from a member sought some structure: "How would that work?"

"Darned if I know how it gets done, but here's how it works," I chimed in. "Yesterday a group of our neighbors gathered in the middle of the street (only one was driving a car) and simply hashed out who would be free on the specific days when another neighbor needed a ride to the city for medical treatment. With five minutes of planning and 15 minutes of unrelated gossip a schedule of drivers was arranged." From the other end of the table came: "Well, that's Longbranch. Longbranch is a community and not just a place where people live."

Anna Gonzales blew onto the Peninsula with all the determined force of a woman with a single-minded mission. Her mother was ill, seriously ill, and Anna had every intention of scooping Carmen up and carrying her back to the bosom of her children and their families in the Southwest. Carmen and hubby Don were to have little if anything to say in the matter. After all, this was family! Anna accompanied her mother to the last LIC meeting. Carmen was met at the door with hugs, hellos, and sympathy barely disguised within gentle humor. Some were wellwishers.

... Some shared advice and their own experiences. Some offered time, a meal for when schedules were tight, a ride to an appointment, even a shoulder for things weighed down heavily. Anna, and for those that know her, this is an amazing thing to say, silently shadowed her mother. For the rest of her week-long visit Anna helped answer the ringing phones. Some enquired after Carmen. Some offered prayers, some more material aid. Some told jokes. On the last day of her visit Anna packed a suitcase. With her clothes. "Mom has family here," she said. "Just not blood family. But family just the same."

Now, I suppose that either of those two stories could have found their way into our 884- column, that grab-bag of tales about the specialness of our Peninsula. They are also a call to action. We're all blessed with some pretty special neighbors down here. They quietly and without fanfare go on about the business of keeping this a very special place.

Let's declare October "Bake A Pie Month", and take one warm from the oven over

to a neighbor you know or haven't met yet. If you'd rather, make that a plate of cookies instead of a pie. If baking is not your thing, pop the top from a bottle that goes glug-glug. It's all part of keeping this a community, rather than just a place where people live.

General Meeting Minutes MINUTES 09-19-07...

Board members present were:

Dennis Stu Stuhaug, President John Biggs, Vice-president Tim Heitzman, Treasurer Patricia Latshaw, Secretary Dean Latshaw, Dock Chair Carolyn Wiley, Events Chair Sue Stuhaug, Membership Chair

The dessert meeting was called to order by President Stu Stuhaug.

In a special note, Marguerite Bussard was recognized in the audience. She has been a member of the Longbranch Improvement Club for 57-plus years!

Motion to approve the minutes as written was seconded and passed. Old Business: None.

Chair Reports:

Events - Carolyn: October has no events except for Trunk or Treat... Debbie will share more later. The Labor Day Dance was successful - thanks to Mark Runions, the band was great and they will be back in 2008. Ray Tossavainen was the ONLY member here for cleanup after the dance. Harold Schlenker has cleaned up the store room and it looks great. Wiley expressed strong hope that the clean condition will be maintained. Mark and Carolyn are working on Beyond the Borders for next year. Bat houses need to be installed . . . they were found in the back room during clean up. Several pictures were also found and they are now being displayed at the club. The exercise class has space for more participants. It was noted that only a few LIC members were at the Labor Day Dance. Secretaries note...more members might show up if they could just have a social night and not be expected to work? Debbie Earhart, co-chair of the Trunk or Treat Program: Trunk or Treat is on 10-31-07. Cars can start parking at 5:30pm and the Evergreen PTA will be hosting the inside for "hay find for prizes"... cupcake walk, hot cider and cocoa. Lynn Carr has made recycling bins for the club and dock. "SOMEONE" has come to the club and emptied our aluminum barrel...for their profit and not the LIC's. Suggestion as to label with a sign that says: Recyclables for LIC Scholarship Program.

Treasurer - Tim: Investment notes renewed at 5.15%. Club finances in good position, but insurance renewal is due next month-approx. \$14,000. He suggested a policy review again next year, but we do get a good deal. Tim has spoken with other groups and we have a really good insurance rate. The club has 66k in bank, 18k liabilities. Net worth is approx. \$78K. Chairs have been frugal and income is above expectations. Rentals are up \$800 over the projections, dock income is up \$1600. Total events are \$1500 above estimate.

Meeting Minutes Continued . . .

Membership - Sue: New member Kelly McKellips ... not at the meeting, but does a lot of work as bouncer at the dances. Thanks to our hostesses tonight. Thank you to Carmen for greeting tonight. She is having a second surgery tomorrow for her breast cancer. Thank you from Carmen for the gift and card. Alice Schlenker is home tonight because of a second round of chemotherapy. Our thoughts and prayers are with her during this difficult time.

<u>Dock</u> - Dean: Pierce County inspectors were out to check over the wharf to our dock/marina (from parking lot to ramp), and informally warned of the possibility of condemnation! County cannot give shoreline property away and the structure is not part of a viable roadway - so no support. Inspectors suggested that the LIC contact state-local elected representatives in an effort to line up grants and public money for repairs/replacement. They warned that the bridge structure may collapse during a future earthquake. Marine Floats offered a potential plan for marina expansion, with a base estimated price of about \$314k, not including wiring/electric, fire stands, water, etc. Current utilities may have to be upgraded during any expansion. Any plans for marina wharf renovation must await a written report from the bridge inspectors and Pierce County action. On the positive side, the LIC has the opportunity to really change this and spruce it up. IN related dock matters, a reduction in the number of dumpsters and location is contemplated. Copies of the Washington Best Management Practices plans will be included in future moorage renewal documents. The dock gate will remain unlocked during daylight hours, as part of the marina's agreements with the state Dept. of Natural Resources and Pierce County. With the onset of winter (winter moorage begins Nov. 1, 2007, signup is now), boat owners were cautioned about inadequate moorage lines as well as electrical usage which now will be monitored. LIC members have first priority for winter moorage slots.

Meeting Minutes Continued . . .

Edie Morgan spoke about the Mustard Seed Program (Article in Sept. Newsletter), the Peninsula-wide effort to develop a more elderlyfriendly region. She invited LIC members to the Mustard Seed open house from 4 - 7 p.m. Sept. 28 at the Key Center Senior Center (next to the library). They have 18 volunteers and are looking for more. The info center will be staffed from 9am to 1pm Monday through Friday. Services and programs that currently exist are disabled services, 65+ services, transportation, tax relief, health and wellness and more to follow. Please come and volunteer if you can. Community Fair - Mike Hays, who also serves on the Community Fair board, was to have reported on Fair activities but had been unavoidably detained. It was noted that the LIC needed four representatives on the Fair board (as one of sponsoring organizations) but had three vacancies to fill. CC Williams and Sue Stuhaug volunteered for two of the open spots. Average attendance for the fair was about 4000. They actually need 5000 to 7000 to really improve. Key Pen population is 15,900. So far, not a really good turn out from the locals. We will have a different structure at the October meeting. At 6pm, there will be a presentation regarding the 302 interchange possibilities. 1/2 hour presentation and then we will have our potluck and meeting. Potluck will begin at 6:30pm.

Vice President John Biggs talked about the marina issue, stressing the need to think outside of the box with thinking of the marina's future. Public money, such as through the State of Washington, has to be funneled through a public agency ... i.e. Pierce County, Port of Tacoma ... and not LIC due to tax status. No agency will give that kind of money without enhancement to the public - \$ won't go to the LIC alone. Audience members raised the question of creating a LONGBRANCH PORT AUTHORITY, not dissimilar from that in Allyn. If one was formed, it could also then handle policing of derelict vessels. Opportunities exist - we just need to pursue them.

Meeting Minutes Continued . . .

Need someone NOW to spearhead and run with this - we need a leader who will take charge and own it. We can't sit around and talk about it for a couple of years and only then decide. Motion was made, seconded and passed for the board to form/appoint a committee within 30 days with an outline for planning/process to address the marina issue. Great opportunity but we need to grab the bull by the horns and get on with it. Again, this is not a dock committee issue. This is legal and needs to be handled just by those with experience. Raffle - Marilyn: Not happy with raffle situation. In the past, she has raised at least \$60 per raffle and tonight there were only \$20 in donations for the 50/50 raffle. Stu Stuhaug asked that she come to the next board meeting to discuss. Sue Stuhaug won the raffle and donated the money back to the scholarship fund. We need hostesses for next months dinner meeting.

Meeting adjourned at 8:30 p.m.


