### President's Message:

At the November Board meeting, the LIC Board will be preparing the 2017 budget. Our reliable treasurer, Jim has provided each Board member with detailed income and expense totals not only for this current year but for the prior two years. With this information, each Board member will recommend income and expense projections for his / her area of responsibility for the coming year. The 2017 budget will be presented and reviewed at the January General Meeting for membership approval. Members of the LIC should be proud that over the last few years, the LIC has presented a balanced budget to the membership for approval and is in a healthy financial position. Being in a healthy financial position has meant that the LIC has been able to meet the monetary match requirement for the Pierce County Historic Preservation and Landmarks Commission grant, retire several promissory notes early, prepare a 15 year plan for funding the upgrades at the Marina and budgeted and awaiting the final permits to remove and replace several pilings at the dock. If you have questions or suggestions regarding the new budget, please call me or any of the Board members who will be happy to hear from you!

The November General Meeting on November 16th will feature a speaker provided by Humanities Washington. Llyn DeDanaan is an anthropologist and author living in Shelton. Her book "**Katie Gale : A Coast Salish Woman's Life on Oyster Bay** " was published in 2013. Her talk will be about the people and the artifacts that helped stitch Katie Gale's story together and will help guide us in uncovering our own "backyard" history tale. *Please remember to bring your neighbor, a history buff or a friend to the meeting.* It should be a wonderful evening in our own "Princess" Fil Lucy Bay.

With Thanksgiving around the corner, I am filled with **gratitude** for this community. You respond when the call goes out for help and jobs get done. Within the last two months Club members have worked together on a Saturday morning to prep the Clubhouse prior to having the exterior stained, all the specific sections of the Historic Preservation grant were completed prior to the deadline, the DNR Committee has continued to work on the DNR negotiations and lease renewal, the Fiber Arts event was very successful with happy vendors and a record turnout of visitors, a delicious lunch for the Fiber Arts attendees was prepared by the kitchen crew, an application for a Washington State Capital grant for safety improvements at the Marina has been prepared, a Haunted House was built and Trunk & Treat was enjoyed by children in our community, the LIC ad hoc insurance committee has been working on the renewal for both the Marina and Clubhouse, and our grass field has been cut by our trusty mowing crew. Volunteerism is alive and well in our community! Thank you all for your enthusiasm, hard work and friendships.

## LIC General Membership Meeting

October 19, 2016

The meeting was called to order at 7 p.m. by Fancie Carr, president.

New members were introduced: Tom Tallman, Patrick and Kathleen (Kat) Supplee and Bart Magnuson.

### **BOARD REPORTS:**

**Secretary:** Jane Eiseman asked that the Minutes of the September 21st meeting be accepted as written. MSP. She acknowledged receipt of a letter from the Children's Home Society thanking the LIC for its \$100 grant to purchase nutritious snacks for the girls in their "Little Toasters" after-school program.

**Treasurer:** Jim Hettinger announced that the net income for the year thus far is over budget. The tax return for 2015, due net month, is almost ready. Fiber Arts was a huge success: Revenue budget was \$1,500 and the income from it was \$3,047.

**President:** Francie Carr welcomed back Harry Faas after his accident.

She asked for a change to SFive of the by-laws such that each committee shall be entitled to only one vote on Board actions. This has to be presented twice to the membership, thus it will be voted on at the November meeting.

The speaker for the November meeting will present a talk on the topic of "History in Our Own Backyard". This would be a good opportunity to invite a friend and/or a neighbor to an LIC meeting.

**Vice-President:** Clark Van Bogart reported that the approximately \$240,000 grant request to the State of Washington is ready to be submitted. The grant, a reimbursement grant, is for improvements to the Marina, which will address environmental concerns and public safety. The office of our State Representative, Jesse Young, has been notified of its completion.

Newly designed donation cards for the Longbranch Foundation, a 501c3, were distributed. On the card there is a list of six different options to which a donation may be designated.

A donor mailing to all LIC members and to a few selected others will be sent out in early November. This will offer the same six choices that appear on the donor card posted on the website.

### **COMMITTEE REPORTS**

**Events:** Jan Brown and Kathy Lyons passed around sign-up sheets for volunteers for Trunk or Treat, which is a joint venture of the Evergreen Elementary School and the LIC. People are needed to work both inside the Club House and outside in the field. One and possibly two officers from the sheriff's department will help with the automobile traffic.

Nancy Carr reiterated that Fiber Arts was a rousing success. Most of the survey responses were very positive. Fourteen of this year's vendors have already registered for next year.

**Building and Grounds:** Sharon Gearhart reported that the grant work on the building is almost completed, except for the windows. The report on the work, due November 15, is being worked on now. Changes have been made to the LIC Rental Forms, specifying house rules and insurance coverage, for example, and reflecting overall rate increases of approximately 25% for rentals. She asked the membership for approval. MSP.

**Marina:** Mark Runions asked for clarification on the Marina budget. Jim said repeated that the Marina is way over on revenue and under on expenses.

At least one hundred feet are booked so far for winter moorage. There is space available on a temporary basis.

Negotiating for the removal of the final boathouse is underway.

The piling project is awaiting the final sign-off of the permit from the Federal Fish and Wildlife Department, which is part of the Army Corps of Engineers.

Robert Theison informed the boat owners that both their own names and the name of Longbranch Improvement Club must be on their insurance form, as an additional insured.

He has been dealing with Pierce County and technically the parking lot is a road. The area will be surveyed, the brush cut back, and the parking lot may be expanded and striped.

**DNR:** Denny Pritchard informed the membership that there is a new person at the Department of Natural Resources with whom he is working on the non-water portion of our lease (e.g., the pavilion).

**Membership:** Nancy Carr expressed thanks for tonight's kitchen crew. She said that at the November meeting there will be a silent auction to help fund Kids N Christmas. Contact Nancy if you have item(s) that you wish to donate. Kids N Christmas is a family event; free meals, photos with Santa, gifts and activities. A lot of volunteers are needed for this event.

The general membership meeting for December will be held on **December 14th** instead of the 21st. The Key Center Singers will provide the entertainment.

Nominations are being taken for Star and Lifetime Achievement awards to be given out at the December meeting.

Pat Muchmore explained that the **road clean-up** had to be canceled due to rain and the heavy winds that were predicted. Weather conditions being what they are during the fall and winter months, we may want to wait until next year to reschedule.

The next meeting will be held on November 16th.



## Update on The Longbranch Foundation

The Washington State Community Project Program grant application seeking funding for significant environmental and public safety upgrades at the Marina has been completed to a point where it is ready for submission to Rep. Jesse Young's office. I have been working with them on the grant and I am awaiting their return call regarding the mechanics of submission. The grant application will be submitted on our behalf by our elected representative, so the process undoubtedly is that it will be edited by him/her, and then it is placed in line along with many more from around the State. The House Capital Budget Committee of the State Legislature makes the initial evaluation and passes it on for approval (we hope). I believe we've made a strong case to emphasize the environmental protection and public safety upgrades that are needed so I am hopeful; however, funding depends entirely on the State's priorities. In coming months, I'll keep you posted on its status and seek your help in prompting our elected representatives during the legislative session that begins in January.

We have embarked on an annual donor solicitation. Please look for an envelope in your mail shortly after the first of November. It will be easily identified by the *Celebrate The South Sound 2016* tagline. The mailing will include a donor response card on which you can select the preferred charitable purpose you wish to support. Please be generous and send the card back as soon as you can in the envelope that is included. We live in a wonderful place but there remains ongoing needs throughout the community, so we can make a difference. And remember, donations to The Longbranch Foundation are tax deductible to the extent allowed by law.

This also brings to mind that we have added a donor response card to our website so that you can easily make a donation to the charitable purpose of your choice at any time. Go to our website (see below), click on DONATE NOW, complete the form and mail it in. It is easy and convenient.



## **NOVEMBER MEETING PROGRAM:**


