President's Message

At our June annual membership meeting, a relatively new member came up to me and remarked that he had never been involved with an organization quite like the LIC before. I was a little puzzled at first, but then he commented that he enjoyed being a part of it because no one was fighting and really appeared to get along. It struck me that we do indeed have a good thing going here on the south Key Peninsula. My hat's off to you for maintaining great personal relationships although we may disagree from time to time on few minor things. It's a very remarkable mix of people.

We had a wonderful turnout of more than 90 people at our annual meeting. You elected new board members to two year terms: Bob Perry as Building & Grounds Chair, and Bob Green as Events Chair with Barb Green as co-Chair. Marsha Kremen was re-elected Vice President and Jane Eiseman was re-elected Secretary. I'm looking forward to continuing the work we've been doing as a board in making it possible for the LIC to better our community. I want to thank the outgoing board members for their hard work and service to the LIC over the past two years: Sharon Gearhart (Building & Grounds Chair), Jan Brown (Events co-Chair) and Kathy Lyons (Events Chair).

The LIC has applied for a Pierce County Preservation Grant covering complete repair/renovation of the bank of five large windows on the west side of the building. The project involves the removal of the windows, cleaning and hazardous waste remediation (i.e., lead paint), so the total cost of this project is significant (approximately \$22,800). The County will act this fall on all Grant applications, and if our project is approved, 50% funding will be provided in 2019.

Our marina upgrade project remains in the permitting stage and this process will take a few more months. According to our contractor, the National Marine Fisheries permit process is getting more arduous and our contractor is somewhat concerned about the timing because our Washington grant has time constraints. We're not panicking yet, just somewhat concerned about the time squeeze.

COMMITTEE REPORTS

Membership: Nancy Carr announced that LIC Bucks would be distributed at the next meeting - but would not include volunteer hours for the Memorial Day Dance unless the misplaced sign-sheets are located very soon. She applauded the great turnout for tonight's annual membership meeting - more than ninety people.

Events: Kathy Lyons announced the Fourth of July Dance, to be held on July 7th, with a new band called OuttaControl. Jan Brown brought signup sheets for volunteers and tickets for sale.

Building and Grounds: Clark reported that we have submitted a grant application to Pierce County for a Preservation Grant. The funds would be used to remove and repair the bank of windows on the west side of the LIC building. The approximately \$23,000 cost would be split between grant funding and the LIC.

Marina: Robert Theisen stated that it is no longer necessary for boat owners to list the LIC or TLF as "Additional Insureds" on their boat insurance.

He is waiting on an estimate for a light on the ramp. He is working on the entryway and will be pouring concrete, so he asked that people be careful in that area.

He and Clark have a meeting with the Angel Guild on June 25th regarding an AED for the Marina.

Robert brought a special lip-shaped birthday cake for his friend Delia McGinnis. Clark wished a happy birthday to Dick Van Cise as well.

Sunshine: Cheryl Allen said that it was a quiet month.

Newsletter: Clark presented an apron with the words "Editor Extraordinaire" to Helen Jamieson, our newsletter editor for the past four years. Tanya Perry has agreed to take on the job.

OLD BUSINESS

Clark reported on the status of the Marina grant. At the state level, it is still in the permitting process with the Department of Fish and Wildlife. At the federal level, the Corps of Engineers is required to forward any permits to the National Marine Fisheries for their approval, which is taking a tougher stand on any repairs.
