This Auction is all about the children. All the net proceeds from this auction go toward the Foundation's two main initiatives to support our kids:

Student Programs supports Evergreen Elementary students with scholarships for 5<sup>th</sup> graders to attend environmental camp (check out the thank you notes in the program and on your table at the auction), and money for items that make students feel better about themselves (self-care items) – hygiene kits, shoes, coats, after school programs, and the like.

In 2019 we increased our support to \$1,500 for Camp helping 10 students attend, and plan to spend \$2,000 on self-care items. Our team has identified needs for these students that exceed \$8,000 a year, and that only covers 30-50 of the 130 students in need.

And eventually, the Foundation would love to expand support to the Key Peninsula Middle School.

Higher Education Scholarships are awarded to Key Peninsula High School seniors who have attended Evergreen Elementary. We also support those students who qualify with recurring scholarships while they are in school.

One \$1,500 scholarship pays for an entire quarter at Tacoma Community College.

In 2018, we awarded \$8,000 in scholarships to attend college, and to students already in college whom we have supported in the past. In the future we hope to increase the number of new scholarships we award, as well as continue with recurring scholarships on a selective basis. In addition, we are looking to increase our planned dollars, so we can expand to Trade School and Vocational Training scholarships in addition to College Scholarships.

## Plum Galette

Contributed by Jim Sobiek (Jim saved a lot of work by just using store bought puff pastry).

The amount of sugar needed depends on the tartness of the plums. If all you have are fairly ripe, and therefore fairly sweet, plums, use a little less sugar.

If using salted butter, omit the salt in the crust.

Prep time: 15 minutes

Cook time: 45 minutes

Making homemade crust time: 1 hour, 20 minutes

Yield: Makes 6 servings

### INGREDIENTS

#### **Crust:**

1 1/4 cup (160g) all purpose flour

1 teaspoon sugar

1/2 teaspoon salt

5 ounces of unsalted butter (1

1/4 sticks, 10 Tbsp, 137g), cut into cubes

1/4 cup (57 ml) sour cream

1 egg, beaten, for egg wash (optional)

1 teaspoon cream for egg wash (optional)

Coarse sugar for sprinkling (optional)

#### **Filling:**

6-8 tart plums and/or pluots, pitted and sliced (about 1 1/4

pounds or 570g)

1/3 cup (70 g) sugar

1/8 teaspoon cinnamon

1 teaspoon lemon juice

1 teaspoon orange (or lemon) zest

1 teaspoon quick tapioca, or a tablespoon of flour (for thickening)



1 Make the dough for the galette: If making a homemade crust, make the dough at least an hour in advance. Whisk together the flour, sugar, and salt in a large bowl. Add the cubed butter to the dough and use your (clean) hands or a pastry blender to work the butter into the dough until the mixture resembled crumbs, with pieces of butter no bigger than a pea.

Add the sour cream to the mixture and mix in with a fork. Gather the dough into a ball with your hands and flatten into a disk shape. Wrap with plastic wrap and chill for at least an hour (it will need chilling to firm up) before rolling out.

2 Toss plum slices with sugar, cinnamon, lemon, instant tapioca: In a medium sized bowl, gently toss the plum slices with the sugar, cinnamon, lemon juice, zest, and instant tapioca (or flour).

3 Preheat oven to 375°F (190°C).

4 Line baking sheet and roll out dough: Remove the pie dough from the refrigerator to let stand for 5 minutes before rolling out. Line a baking sheet with

parchment paper or a silicone mat, or lightly butter a baking sheet. Lightly flour a clean surface and roll out the pie dough to a 13-inch round of even thickness.

5 Arrange plum slices in center of dough round, fold up edges: Place rolled-out pie dough in the center of the lined or buttered baking sheet. Arrange the plum slices in a circular pattern, starting from 1 1/2 to 2 inches from the outside edge of the dough, working your way into the center. Fold the edges of the pie crust up and over so that circle of the filling is visible.

6 Brush with egg wash, sprinkle with coarse sugar: If you want an attractive finish for the crust, whisk together the egg and cream in a small bowl. Brush on the exposed pastry crust with a pastry brush. Sprinkle with some coarse sugar.

7 Bake: Place in the middle rack of the oven. Bake at 375°F (190°C) for 40-50 minutes, until the crust is lightly browned and the filling is bubbly. Cool on a rack for an hour before serving.

Marsha Kremen, President, called the meeting to order at 7:00 p.m.

New members were introduced: Karin Gruver, Garry Schneider and Margaret Golston.

Don Berger introduced Emily Erhardt, the 2019 Longbranch Foundation scholarship recipient. Emily attended Evergreen Elementary and recently graduated from Peninsula High School where her favorite classes were pre-calculus and chemistry. Emily plans on attending TCC this fall to work towards her associate's degree, and will then transfer to Gonzaga, which has a great study abroad program, or WSU, in order to reach her goal of working with NBA teams. Emily thanked the LIC members for choosing her for the scholarship, stating that it was an absolute honor and she is so grateful for the opportunity given to her.

Randy Carr paid tribute to Emily's father, Glen Erhardt for his hard work in securing the floor in the LIC clubhouse many years ago.

Randy introduced Signo Uddenberg, who is the immediate past board president at Peninsula Light. Signo then introduced Mike Simpson, the Chief Operating Officer. The following is an excerpt from his presentation: 120 hours were spent on the "Snowmageddon" storm restoration this past winter. Every substation but two were out of power at least once. Contractors, exempt employees and other power

companies helped out during this crisis. Peninsula Light was able to communicate updates with their members through social media, including Twitter posts, Facebook feeds and discussion groups which were monitored consistently. The following areas of opportunity based on lessons learned from this event will be addressed: 1. In the process of working on a design to be able to open and close circuits automatically. 2. Install tree wire for those areas that can't have underground wiring. 3. Vegetation management. 4. Schedule quarterly meetings with Tacoma power to review all standard operating procedures. 5. Reevaluate all backup systems. 6. Additional training 7. Use systems more routinely.

Marsha introduced the new Key Peninsula Fire Chief, Dustin Morrow. The following is an excerpt from his presentation:

The KP fire department is a top to bottom fire service that is small, but well equipped. Most calls are EMS or rescue related. The fire department funding comes from the regular fire levy, EMS levy, M & O levy and fees for service. The current levy passed in 2010 for 10 years, and was essential to maintain services in the community. Based on assessed valuation, there is a widening gap between potentially available revenue in 2010 versus today. Expenses have out-paced revenue. Dustin is hoping to replace the existing EMS levy one year early with the same \$.50/1000 valuation and to make it a permanent levy. In order to pass, a super majority of 60% is required. He is asking us

### BOARD REPORTS

Secretary: Kim Robinson asked that the minutes of the June meeting be accepted as written and submitted. MSP

Treasurer: Jim Hettinger was not present. Marsha noted that the LIC had a net income of \$5700 over budget for June. Year to date, we are \$24,000 over net income compared to budget.

Membership: Nancy Carr stated that the LIC bucks are in the nametags, and to check the sign-up sheets to make sure your hours are correct. If your hours do not add up, please let her know.

Events: Bob Green stated that an events committee meeting will be held on Wednesday, July 24<sup>th</sup> at 3:30 and all are welcome to attend. The Labor Day dance is on Aug. 31<sup>st</sup> and the band Copasetic will be playing. Volunteers are still needed. The Key Best committee members have been working hard. Food station, bartender, barback and rover positions are still needed. A volunteer list was passed around with the positions still needed to be filled.

#### Building & Grounds:

Bob Perry shared that volunteers are needed for facility cleanup the day of the Key Best auction, Aug. 3<sup>rd</sup> at 1:00 p.m. for a couple of hours. He also needs volunteers for grounds maintenance, which includes mowing and weed whacking of the trails. We now have a riding lawn mower that was donated to us,

but if you would like to bring your own mower that would be helpful. Bob will provide beverages. Mowing can be worked in sections to accommodate availability. On August 9<sup>th</sup>, a 1000-gallon propane tank will be installed and we will bring in new gas service. This will provide the LIC with a yearly net savings of \$2500, and we should financially break even within 3 years. Volunteers are needed for trenching at the LIC on Saturday, August 10<sup>th</sup>. Both an irrigation line, and power for lights, will run out to the Longbranch sign. New security cameras have been installed around the building, and another camera will be installed at the Longbranch sign in the future.

#### Marina:

Robert Theisen stated that the internet at the marina is now working. When signing in, bypass the guest sign in, which only allows access for 24 hours before you have to sign in again. Bob Perry and Robert are working on a security system plan at the marina for the future. If you are taking out your boat for an extended time, do not leave your car in the parking lot. There is a limited amount of parking and the LIC is not responsible for any damages.

#### Trustee at Large:

Clark Van Bogart revealed the Toro mower that his neighbor and fellow LIC member Eric Fleischman donated to the Longbranch Foundation. Please thank the Fleischman's when you see them at the LIC.

#### Newsletter:

### Historian:

Lynn Larson does a scrapbook for every year. She has completed year 2006 and should have 2005 completed by next month. Carolyn Wiley made a recommendation that these scrapbooks be displayed on tables at events such as the Livable Community Fair and Fiber Arts so people can flip through them.

### Vice President:

David Zeigler stated that he is happy to be involved with the LIC and will do whatever it takes!

### President:

Marsha Kremen gave an update on the Pierce County Preservation Grant. We are still being recommended for 100% funding and should know more early next year when it goes before the county council. The board has authorized a committee to research the possibility of putting a pump out station at the marina. Part of the reason for this decision is the fact that agencies, including the county, want us to do this because there are so few pump out stations in the South Sound, and part of our mission is to protect Filucy Bay, and this would certainly help with that. Brett Allen has been elected to run the committee, and he has chosen his members. The committee has already had their first meeting, and are charged with looking at existing pump out stations, getting estimates, and working on a grant application for initial costs, such as

permitting and other preliminary issues. We have not committed the LIC to any money or upfront costs at this time. At this point, this is purely exploratory.

### **The Longbranch Foundation:**

Barb Floyd gave an update on the Key Best event which will take place on August 3<sup>rd</sup>. People have been working for months on this event. We already have \$13,000 from sponsors and donors. If you are unable to attend, we will gladly accept your contributions now! The festivities include Steve Nieto, who will be playing smooth jazz, great food, and an amazing list of auction items procured by Kelly Hettinger and Barb Van Bogart. All money made from Key Best will go towards the Evergreen Elementary students and scholarships.
