Nick Bond is the Washington State Climatologist, a position created by the State of Washington to serve as a credible and expert source of climate and weather information. He earned a PhD in Atmospheric Sciences from the University of Washington, and is now a principal research scientist with the Joint Institute for the Study of Atmosphere and Ocean with

the College of the Environment. Bond is on the Science Panel for the Puget Sound Partnership, which focuses on the actions needed to recover and sustain the Puget Sound ecosystem.

We are in the process of implementing a new volunteer hour tracking system, and a short demo was provided at the August Membership meeting. Some of the Board has been using the trial version for the last month and has been very happy with how easy it is to use either on a pc or from an app for your phone. If this is something you are not comfortable using, no worries – you can still use paper forms or e-mail. I will be setting current members up (a few at a time) and you will receive an ‘invitation’ from me through the system with the steps to setup a user id/password to begin reporting volunteer hours. I will send out an e-mail right after the invitation is issued so you can make sure it gets to

your e-mail, and is not caught in a spam filter. We have the system set up, so you can report your time in different categories, some for TLF, the LIC and the Marina. There is also a field to populate with the task you are performing. One of the neat features of this software is the reporting.

I know you will have questions, I certainly did when I was testing, so don’t hesitate to let me know. We will be happy to setup of training sessions, as needed, or help with step by step directions. Stay tuned, more to come later.

The purpose of our biennial Auction is to put in place sustainable plans to fund Student Programs and Higher Education Scholarships. Your generous donations from the 2017 Auction and the yearly Celebrate Campaign established a plan that recently funded the following Student Program at Evergreen Elementary.

Our Student Program co-chairs Jan Prichard & Kim Robinson report:

Thirty-nine students from grades K through 3 were picked by their teachers to attend a free, three week "camp" at Evergreen to help them with their reading skills. A grant from Rotary North and funds from Peninsula School District paid for a paraeducator all day; Food Backpacks 4 Kids provided breakfast, lunch and snacks, Children's Home Society paid for afternoon teachers; and Community in Schools paid for Tricia Endsley, who put it all together, with the help of a great group of volunteers.





On the last day of camp, August 8,

The Longbranch Foundation provided all the school supplies that each student will need to start a successful school year at Evergreen. Using money from our last Auction, and contributions to our yearly Celebrate campaign, Jan and Kim put together “Back to School” bags of supplies. We were so pleased to partner with CIS and be a part of this great collaboration.

The past month was a busy time for working on the LIC. A huge slate of volunteers helped with one of our most ambitious projects over the last few years – the trenching and installation of a new 1,000 gal LP tank, and trenching for water and power from the Clubhouse to the new sign – total trenching of over 700 feet. Helping the cause was John Schell, Jim Sobieck, Harry & Brynn Rydell, Bill & Lynn Lloyd, Bob Green, Steve Kuresman, Dustin & Garrett Morrow, Clark Van Bogart, Larry Silva, and Jan Brown, all who came with shovels and rakes to support the cause.

The county has inspected, and trenches have been covered. Water is now flowing to the new sign area, so it can be easily watered, and the next steps in the attachment of the new LP tank to building will be taking place in the next few days.

On a separate note, most members are aware that we have video security covering our grounds and building interiors. From time to time, members park their cars in our lot as they carpool together. We have had problems in the past with non-members parking and storing vehicles and RV's, which is a major risk and cost to the LIC. If you plan to park your car during the day at the LIC, and it will be unattended, please text Bob Perry at 714-345-7745 with a note, including your car make and color, so he knows it's not abandoned. And please, no overnight parking, and as normal, parking is at your own risk.

LIC General Meeting August 21, 2019



Marsha Kremen, President, called the meeting to order at 7:00 p.m. and wished a happy birthday to Bert Magnuson. There were no guests or new members.

BOARD REPORTS

Secretary: Kim Robinson asked that the minutes of the July meeting be accepted as written and submitted. MSP

Treasurer: In Jim Hettinger's absence, Marsha shared, that we are over our year-to-date income by \$11,000 and below year-to-date expenses by \$10,000, which results in a net income of \$21,000 over budgeted net income year-to-date. Building, Marina and Membership incomes are all over budgeted income year-to-date. Events is under year-to-date income by \$900, but under expense by \$2300, the net income is \$1,400 over budgeted income. The Event budget originally included net income for a 4th of July dance which we decided not to do.

Membership: Nancy Carr gave a Track It Forward demonstration, with the assistance of Bob Perry. In the past, Nancy has spent 40 hours a month tracking volunteer hours. This web-based system should not only help decrease her work load, but make it easier for members to turn in their volunteer hours. We are currently in test mode, and there has been a positive response from everyone who has used it. The tracked hours can be segregated by specific categories, i.e. LIC, The Longbranch Foundation, grants, events, fundraisers, etc. and the number of categories, that can be used are unlimited. The hours can be exported to excel with reporting available. This app can be loaded

on a phone or can be used on the web for more convenience. If there are members who do not want to use this app, Nancy will still accept a sheet of paper. Because we are allowed only 100 users for the amount we pay, couples will be set up as one user. Otherwise, our price would double. Nancy will send an email to all members with links and steps to take. This is a very straightforward and user-friendly system; however, classes can be set up for more instruction if needed.

Events: Bob Green stated, that the Labor Day weekend dance is on Saturday, August 31st. Volunteers are still needed and there is a sign-up sheet. The marina has no reservations, so we will not be running a shuttle this year. Tickets are available at The Blend, Sunnycrest Nursery and the Marina. The band Copastetic will be playing. Nancy gave an update on the Fiber Arts event, which will be held on Saturday, October 5th from 10:00 a.m.-4:00 p.m. All inside booths are sold out. We have 12-14 outside booths sold, and can still take more registrations. Bertinelli's coffee will be there. Mary and Ann Marie have set the menu, which will include tomato basil soup, tacos in a bag, and gyros in a bag. The farm tour itself is two days this year, but we are only participating one day. The shuttle stop will be here Saturday. Robert stated, that Carolyn Wiley will be getting a scout boat for the marina. He is asking for volunteers to help at the marina and to help with parking at the LIC. Food will be provided for the marina volunteers this year.

Building & Grounds: Bob Perry thanked all the volunteers that helped out last weekend and Monday. 600 feet of power and water lines out to the sign were buried. A special thank you went out to the new fire chief, Dustin Morrow, who brought his excavation equipment. We will add a sprinkler out there and lights on the sign. A permit was issued by Pierce county last night, the pipes were inspected today and the trenches were covered up a few hours ago. It will be connected and converted over fairly quickly. A 1000-gallon LP tank was put in. We paid \$2,500 for the tank. It cost \$2.47 a gallon last December to fill the smaller tanks. We just paid \$.92 a gallon to fill the new tank, which won't need to be filled for another year. The tank will pay for itself within a couple of years. Bob is working on the budget for next year which will include a 40 ft cargo container. When we buried the pipe, we added boxes every 100 feet that we can dig up and get power. The plan is to pull power to put up lighting in parking lot, and perhaps have lights in time for the Trunk or Treat event. Feel free to share any suggestions you have for the Building and Grounds budget with Bob.

Marina: Robert Theisen states that permanent moorage is full until October.

Trustee at Large: Clark Van Bogart had nothing to report.

Newsletter: Tanya Perry asks that any articles you want in the newsletter be sent to her by the 25th of each month.

Historian: Lynn Larson completed the archives and notebook for 2005. There were many events that took place that year such

as the Raise the Roof auction, fundraising for the Evergreen Elementary reading room, and many holiday dances including Valentine's Day, Memorial Day, Labor Day, Halloween and New Year's Eve. If anyone has anything from 2005, please let Lynn know. She is starting to compile a list of past LIC presidents.

Vice President: David Zeigler had nothing to report.

President: Marsha Kremen shared the pump out station status. Sheryl Low is working with the county grant writing process. We have gotten letters of support from the county. Everything is moving quickly. We need leaders for the spring garage sale. Planning will need to start as early as September or October. The bulk of the work for this event takes place 2-3 days before the event and the day of. The Pritchard's left detailed documentation, including who and when to contact people. There is also a mailing list for booths. The planning is straight forward. The LIC will turn 100 years old in 2021. We need to start planning the centennial celebration next year. We would like to have historical presentations by people who have lived here a long time. Should we have a Civic Center vs. LIC baseball game since baseball was such a big part of the community's history?

The Longbranch Foundation: In Barb Floyd's absence, Marsha gave an update on the Key Best Demin and Diamonds event, which was highly successful. Our Gross revenue was \$10,000 over the original goal of \$65,000, thanks to Laura, our auctioneer, and all those that worked so hard for this event. There are no final numbers yet, but an update will be

Gina Cabiddu, a former scholarship recipient and guest speaker received a standing ovation. We are in the process of getting permission to publish a video that was made by an audience member.
